### WAIVER, DISCHARGE AND RELEASE FROM LIABILITY

Please read carefully, and fill in the blanks where appropriate.

1. I \_\_\_\_\_ hereby confirm that I fully understand all the inherent risks of utilizing the skate and/or surf park. I also confirm that I am fully aware that skating/surfing is inherently dangerous and can lead to personal injury, death, property damage and/or other consequential loss. I voluntarily accept these risks.
2. In consideration of being allowed to use the skate/surf park and the skate/surf park facilities I hereby agree that: i.) I release and discharge Black Pearl Parks Ltd. ("The Owner"), all of the instructors and professional/amateur skaters at Skate Cayman, the Cayman Islands Department of Tourism and Missy Farren & Associates, Ltd. d/b/a/ MFACTION and each of their respective parents, affiliates, subsidiaries, members, managers employees, principals, officers, directors, agents and volunteers (hereby known as the "Indemnitees") from all and any liability for loss and damage I may suffer arising out of my use of the park and its facilities. ii.) I waive all and any claims for loss and damage that I may have against the Indemnitees arising out of my use of the skate park and its facilities. iii.) The release, discharge and waiver in relation to loss and damage includes, but is not limited to personal injury, death, breach of contract, breach of common law duty, negligence howsoever arising, loss of profit, indirect special or consequential loss, costs, expenses, and any other claims. iv.) I indemnify and shall keep fully indemnified the Indemnitees against all claims, costs and expenses (including legal costs) in respect of any liability to third parties arising out of my use of the skate/surf park and its facilities.
3. This release and discharge and indemnity extends and shall be binding on my heirs, next of kin, family, relatives, guardians, executors, administrators, trustees and assigns in the event of my injury, disability or death.
4. In the event of a dispute with the Owner and/or the Cayman Islands Department of Tourism this agreement shall be governed by and be construed in accordance with the laws of the Cayman Islands, and I irrevocably submit to the exclusive jurisdiction of the Courts of the Cayman Islands.
5. In the event of a dispute with Missy Farren & Associates, Ltd. d/b/a/ MFACTION this agreement shall be governed by the laws of the State of New York applicable to contracts entered into and to be performed wholly within the State of New York without regard to conflicts of law principles. The state and federal courts located in New York County, New York shall have exclusive jurisdiction over the enforcement of this Agreement."

6. This agreement contains the whole agreement between myself and the Indemnitees and I confirm that I have entered into this agreement only on the basis of representations expressly incorporated into this agreement.
7. This agreement may not be varied, except by an instrument in writing signed by myself and the Indemnitees.
8. I also expressly grant Black Pearl, the Cayman Islands Department of Tourism, Missy Farren & Associates, Ltd. d/b/a/ MFACTION and any third party authorized by each of the foregoing the right to film, videotape, photograph, record the voice of, and make any reproduction of the camper's physical likeness and voice and the irrevocable right in perpetuity to use, display, and digitally enhance or alter in any manner, such likeness in any media now known or hereafter devised, including but not limited to the exhibition and or/online use broad cast, theatrically or on television, cable, or radio, or any motion picture film video tape, DVD, CD, or any published articles in which such likeness may be printed, used, or incorporated, and in the advertising, exploiting and publicizing of the camp and camp products.
9. This agreement is severable in that if any provision is determined to be illegal or unenforceable by the Court such provision shall be deemed to be deleted without effecting the remaining provisions of this agreement.
10. I understand that these clauses are contractual in nature and that I sign this document of my own free will.
11. I hereby warrant that I am of lawful age and legally competent to sign this discharge and release form.
12. If the participant is a minor (i.e. under the age of 18) the undersigned parent/guardian warrants that he/she is the minor's parent/legal guardian and understands that by signing the agreement he/she and the minor have assumed all risks and have waived and released certain rights as set out above and that this extends to heirs, next of kin, family, relative, guardians, executors, administrators, trustees and assigns.
